## **Course Objectives / Learning Outcomes**

This course examines more advanced programming concepts using the Java object-oriented programming language. Topics to be covered include major concepts of object-oriented design, inheritance, polymorphism, string/text processing, wrapper classes, searching and sorting algorithms, recursive programming, exceptions, and advanced file I/O among others.

#### **Evaluation Criteria**

- 1. Labs (10%)
  - Ten weekly labs, worth 1% each
  - Each lab is due at midnight on the day of the lab
  - No late lab submissions will be accepted
- 2. Assignments (15%)
  - Three assignments, worth 5% each
  - Individual due dates will be posted on Nexus

- 3. Midterm Test (25%)
  - During the regular class time (see Important Dates)
- 4. Final Exam (50%)
  - Cumulative
  - Date and location to be announced

# **Course Delivery**

The lectures and the labs will delivered in person on campus. All course material including lecture notes, slides and assignment/lab details will be available on Nexus.

All coding is to be submitted in \*.java format, and any written work in \*.pdf format. Further details and submission procedures will be stated in each lab/assignment. - take care to vet the secondary sources it cites

If students are not sure whether or not they can use AI tools, they should ask their professors.
